Chairman's Report 2023

Dear Member

The Friends of Worthing Hospital formerly known as the League of Worthing Hospitals and Community Friends, was formed in 1949 when it became a registered charity.

Worthing was then a four-ward hospital, the surgical wards were upstairs nearer the operating theatre, the medical wards downstairs, plus an x ray department. The accident and emergency, outpatient department and pharmacy were housed in a separate building that fronted Park Road. Later a separate children's ward was built followed by a new ENT block in the 1950's The League of Worthing Hospitals and Community Friends played a quite different role then, sewing afternoons mending torn bed linen and at the weekends cutting very thin slices of bread and butter for the teas on Sunday afternoon.

How things have changed since then, slowly the original hospital was swallowed up by new buildings

to become what it is today. An increasingly busy six hundred bed general hospital with specialist sections and outlying units in great demand.

Now we are part of the much bigger University Hospital's Sussex NHS Foundation Trust and enjoy meeting our counterparts from all the other hospitals within the Trust.

The role of the Friends has also changed we now help with buying medical equipment for the wards or departments that the NHS cannot always find the funds for due to budget restraints.

We also help to pay for other facilities that both the staff and patients will benefit from, all requests received from any of the department's we care for under both the Sussex Community and Sussex Partnership NHS Foundation Trusts are all given due consideration. Especially the wards at Salvington Lodge, where we have provided a music therapy programme, which is very much enjoyed by the patients. Everyone who has the misfortune to be in hospital at Christmas receives a gift from the Friends and emergency admissions are given toiletry packs. This year (2023) we helped the Breast Care unit with LED wall art, to help the patients relax during their treatment.

Our shop has proved to be a wonderful asset, not only for the staff and patients but also helping to raise funds for The Friends. Mr Terry Lawrence the manager and his staff must be congratulated on keeping the shop open during covid, even though at times customers were few and far between.

Thankfully, the footfall is increasing and having listened to our customers, we have made further improvements to the shop, stocking a larger selection of items including ice creams and can now offer a choice of milks for the coffees and iced teas & coffees.

We are hoping to restart the muchmissed ward trolly and newspaper service which has always proved so popular with those patients unable to visit our shop.

The Committee are now permitted to meet again in the hospital. It is good for us to be nearer the source of the requests and see, what and where help is needed. I must thank all the committee for the support they willingly give me, Malcolm Roberts as Vice Chairman, and Trustees Peter Bandy, Barbara Aldiss, Georgina Fincher Jones, Marva Stanbook and Garry Phillips, also our President John Bull.

Unfortunately, one of our newer Trustees Valerie Walker has had to resign, her expertise and knowledge will be missed greatly.

I must also thank our Treasurer, Sally Jackson and Secretary, Jackie Buss for the work they willingly put into The Friends.

As a committee we are looking for new Trustees, if anyone is interested, please contact the Secretary to have a chat. The AGM for The Friends of Worthing Hospital will be held on Monday 12th June at the Offington Park Methodist Church at 6pm. Light refreshments will be served, and the meeting will commence at 6 30pm. Please do come and join us, there is free parking available.

Trustees report

The trustees present their report with the financial statements of the charity for the year ended 31st December 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1st January 2019).

OBJECTIVES AND ACTIVITIES

The object of the League is to relieve patients of the Worthing Hospitals who are sick, convalescent, disabled, handicapped, infirm and, generally to support the charitable work of the said Hospitals.

Significant activities

The League runs a shop for the benefit of patients and staff as part of its objects.

Grantmaking

The grants committee usually meets every month to consider bids for funding from the local NHS trust supported by the League. Requests for funding are considered primarily for their benefit to patients, staff and visitors.

Volunteers

Due to Covid restrictions, there were no volunteers during 2022.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

The League aims to support the local hospitals by the provision of medical equipment and facilities, amenities such as emergency toilet packs and Christmas presents, and a shop for the benefit of patients, visitors and staff. The League runs the shop as part of its primary charitable activities.

Internal and external factors

The League is reliant on the University Sussex Hospitals NHS Foundation Trust to house its operations. The Trust provides shop space, office and storage facilities within Worthing Hospital.

FINANCIAL REVIEW

Financial position

The shop/cafe made a small surplus in the year, despite being another difficult year of trading. It remained open throughout the year to provide food and drink on a take-away basis. The League spent £17,162 on gifts to local hospitals.

Principal funding sources

The League usually makes a surplus on its trading activities which helps to fund its activities. The League also receives donations and legacies from the general public.

Reserves policy

The League's reserves (unrestricted funds that have not been designated, excluding tangible fixed assets, stock, debtors and an estimate of the following years expenditure) amount to approximately £146,000. Restricted funds total £15,487 and a further £28,706 have been designated for requests that have already been agreed. The remainder of the League's reserves have been set aside in pursuance of the League's objectives when required.

Going concern

There are no material uncertainties which would affect the charity's ability to continue as a going concern.

Funds

The unrestricted fund has been divided into a general fund, and a designated fund. The designated fund represents spending on local hospitals that has been approved by the committee, but has not been invoiced to the League at the balance sheet date. At the year end, the designated fund stood at £28,706. The committee approved spending of £30,056 during the year.

Financial review

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error. Risks to the League are managed by the production of monthly accounts to the trustees and adherence to the constitution, rules and regulations relating to the charity and prudent management of the League including obtaining professional advice when thought fit.

FUTURE PLANS

The League will continue to run the shop/ café at the North wing site.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity's governing document is its constitution dated January 1949, as amended June 1959, June 1969, June 1993 and 16th December 2002. The charity is an unincorporated charity.

Recruitment and appointment of new trustees

We are constantly identifying ways to attract new trustees and anybody interested in becoming a trustee should contact the Chair.

Organisational structure

The committee of the League by whom the business of the League is conducted and managed are its trustees and are throughout this report referred to as the committee. The constitution requires that the committee shall consist of not less than nine persons, no more than seventeen persons: such persons shall be either delegates or elected members. Nornmally there would be a maximum of nine elected members, with a third retiring each year. Due to Covid and related issues, the rotation of Trustees and the introduction of new trustees has been impeded. The current members have been retained through re-election. It is hoped to return to the full provisions of the constitution soon. The committee normally meets monthly to administer the charity and there is a subcommittee to manage the shop.

Induction and training of new trustees

Any new trustee receives a documentation pack produced by ATTEND that states their duties and responsibilities. ATTEND training is available to all trustees.

Main activities undertaken for the public benefit

The trustees have considered the Charities Commission general guidance on public benefit when reviewing the aims, objectives and planned activities of the charity.

Related parties

The League is a member of ATTEND, formerly known as The National Association of Hospital & Community Friends, and has benefited from advice from the organisation. Throughout the year the committee has been pleased to have the help of representatives of local health providers at its meetings.
